

Registration & Cancellation Policy

• Thank you for choosing SciCon Nexus conference (“Conference”). Regardless of whether your registration is submitted by you or your proxy, the following Conferences Terms and Conditions (“Terms”) apply to you and your participation in any SciCon Nexus Conference (both in-person and virtual). Depending on the type of conference, certain terms below may not apply. “Attendee” for purposes of these Terms will include all participants at the Conference, including Exhibitors and Attendees. By participating in this Conference, you agree to these Terms so please read them carefully. These Terms include and incorporate by reference SciCon Nexus’s Privacy Policy. This Conference is organized by SciCon Nexus, which reserves the right, in its sole discretion, to limit or deny access to any entity or individual. To be eligible to participate, you must be 18 years old or older.

Terms and Conditions for In-Person and Virtual/eConference Participation

Terms and Conditions for In-Person Participation

1. Attendee Cancellation Policy

If circumstances change and you can no longer attend this conference, you may cancel your registration by providing written notice to the conference’s email address or via the contact form in the ‘Contact’ option in the conference menu bar.

Please note that the registration fees are non-refundable. However, your fees shall be carried forward to any upcoming conference of similar interest.

Please remember that cancelling your registration does not automatically cancel your hotel and travel arrangements. Attendees are responsible for cancelling their own hotel and travel reservations.

2. Disclaimer

We will endeavour to present the program advertised. However, SciCon Nexus and its partners reserve the right to alter or cancel, without prior notice, arrangements, timetables, plans, or other items relating directly or indirectly to the conference. SciCon Nexus and its partners are not liable for any loss or inconvenience caused because of such cancellation.

3. Insurance

The organizers do not accept liability for personal accident, loss, or damage to private property incurred because of participation in the conference. Delegates are advised to arrange appropriate insurance to cover travel, cancellation costs, medical, and theft or damage of belongings.

4. Photographs and/or videos will be taken during the conference

By taking part in this event, you grant the organizers full rights to use the images resulting from the photography/video filming, and any reproductions/adaptations of the images for fundraising, publicity, or other purposes. This might include (but is not limited to), the right to use them in their printed and online publicity, social media, press releases, etc.

5. Force Majeure.

Payments made are not refundable for any reason, including, but not limited to, failure to attend the conference due to illness or due to any event beyond the reasonable control of the parties, such as an act of God, natural disaster, travel-related problems, or an act of terrorism.

6. Substitution and Badge Policy

Substitution of registrations may be made at any time up to the Conference start date. Certain conferences require Attendees to be qualified by SciCon Nexus to attend and any substitutions would also require approval by SciCon Nexus. "No Shows" will be deemed a cancellation per the Cancellation Policy listed above. Please consult your Conference Secretary with any questions.

Sharing of Attendee badges/IDs is not permitted at any time. Badges/IDs are issued to, can be picked up by, and used by only the Attendee named in the registration. Photo ID will be required for each Attendee when collecting a badge/ID onsite. Badges must be always worn during.

SciCon Nexus conference badge/ID allows an Attendee entry to the overall Conference, but cannot guarantee admission to every session, lounge, or meeting area. Admission is subject to venue capacity and other requirements. For example, certain sessions may be restricted from vendor Attendees.

7. Group Discount Program

- o 1 for every 3 paid registrations

Groups must consist of employees of the same organization and discounts only apply to the same conference. At those conferences where we offer the Group Discount Program, there is a limit of four Group Rate Discount complimentary registrations per organization per conference.

Only one discount may be applied to an individual registration. With the exception of the early bird discount, multiple discounts cannot be combined.

To receive the group discount and be admitted to the conference, all registrations must be paid in full. Please consult the respective Conference Secretary if you have any questions. Group Rate Discount does not apply to Virtual Conference registrations.

8. Payment Terms

Wire transfer, Credit card, and Spot Payments (cash accompanied by Photo ID) are accepted modes of payment towards the conference.

Currency Exchange Rate Disclaimer: The Client/Cardholder confirms acknowledgment and acceptance of a potential gain/loss incurred by any adjustments made by their bank due to the currency exchange rate. SciCon Nexus will not be liable or responsible for any loss incurred by the Client/Cardholder from an adjustment made due to the currency exchange rate. Nor will SciCon Nexus pursue the Client/Cardholder for collection if that adjustment should be made in the Client's/Cardholder's favor.

Submission of a registration online, by phone or email, constitutes an official registration and intent to attend the Conference. Invoices are payable upon receipt, and full payment must be received to gain entry to the Conference.

Until your payment is received you will not have access to pre-conference entitlements that you may be entitled to, such as booking certain sessions. Please note SciCon Nexus does accept cash payments onsite at the Conference accompanied by a valid government-issued photo ID.

You agree that, in the unlikely event that SciCon Nexus cannot resolve your payment issue and you dispute the credit card charge, your statement may be used as evidence that said charge is valid and just.

9. Terms and Conditions: Online/Virtual Conferences & eConferences

By registering for the online conference ("Conference") hosted by SciCon Nexus (conference organizer), you ("Attendee") agree to the following terms and conditions:

10. Registration Fees and Payment:

Attendee acknowledges and agrees that the registration fees are non-refundable. The registration fees are applicable only to the current edition of the Conference for which the Attendee has registered.

11. Carry Forward of Registration Fees:

In the event that the Attendee is unable to attend the current edition of the Conference due to unforeseen circumstances, the Attendee may request to carry forward their registration fees to the next edition of the Conference. The request for carrying forward registration fees must be submitted in writing to SciCon Nexus (conference organizer) at least 15 days prior to the commencement of the current edition of the Conference.
